## C. <u>Adoption of Resolution Declaring the Opioid Crisis a Public Nuisance and Approval of Authority to Represent</u>

Attached is the Resolution and Authority to Represent in the opioid matter. The Resolution declares the opioid crisis a public nuisance. In the Authority to Represent, the county agrees to hire attorney Michael Jay Fuller, Jr. of the McHugh Fuller Law Group as lead counsel. Under this authority the county will file a civil suit against those legally responsible for the wrongful distribution of prescription opiates and damages caused thereby. Attorney Garry Whitaker will be co-counsel and contact person for the county. The agreement provides a twenty five percent (25%) contingency fee with total fees and expenses not to exceed thirty five percent (35%).
