EXEMPTION: General Statute 105-277.1 Property Tax Homestead Exclusion for Elderly or Disabled Persons: North Carolina excludes from property taxes a portion of the appraised value of a permanent residence owned and occupied by North Carolina Residents who are at least 65 years of age or are totally and permanently disabled, and whose income does not exceed the current set limit. The of the appraised value of the residence that may be excluded from taxation is the greater of the current set amount or fifty percent (50%) of the avalue of the residence. Income means all monies received from spouse, lineal ancestor, or lineal descendant. If you received this exclusion last year, you do not need to apply again unless you have changed your permanent residence. If you received the exclusion last year but the property no longer qualifies for any reason, please notify the assessor. Failure to notify the assessor that the property longer qualifies for the exclusion may cause the property to be subject to discovery with penalties and interest pursuant to G.S. 105-312. If you did not receive the exclusion last year, but are now eligible, you may obtain an application from the county tax department. It must be filed County assessor by June 1. Inquire at the County Tax Office for current income and exemption limits. General Statute 105-277.1B Property Tax Homestead circuit Breaker Deferment: Upon application North Carolina defers a portion of the property taxes on the appraised value of a permanent residence owned and occupied by Carolina resident who has owned and occupied the property for at least five years, is at least 65 years of age or is totally and permanently disab whose income does not exceed the current set limit. Depending of the owner's income, the maximum amount of property taxes paid may be no than five percent (5%) of the owner's income with the balance being deferred.
